However, on 16/04/21, the crew on board M/V "KIARA" – A CMA-CGM vessel - underwent a routine COVID check. 4 crew members were found affected. The vessel was hence isolated at anchor for 7 days, after which she was allowed to berth and proceed with the cargo ops.

The population on the whole island is creating havoc by blocking the roads and creating very long traffic jams. Travelling to and from the Port of longoni is getting rather painful.

There is a control of compelling reasons for travelling from Mayotte to the rest of the national territory. Travelers must submit a justification of compelling reason to the prefecture up to 6 days before the date of the flight. This measure has taken into effect since 3<sup>rd</sup> March 2021.





 $\Box$  CONFINEMENT : The massive gathering of people (more than 50 persons) is prohibited. It is obligatory for all citizens in the Albanian territory to wear a mask in closed public spaces. The children younger than 11 years and other persons that cannot wear a mask on health reasons are excluded from this obligation. Currently there is a curfew during period 23:00 – 06:00.

□ NON ESSENTIAL BUSINESS' CLOSURE : Businesses are open, including bars and restaurants, which are required to respect safety protocols.

□ BORDERS' CLOSURE : Land borders of Albania with neighboring countries for the free movement of people are opened. Actually all nationalities are allowed to enter in Albania. Trucks and other cargo movement are allowed and continue normally.

#### 2. Port's situation (max. 10 lines)

All seaports are open. There are no restrictions in handling of cargo vessels, ro-ro vessels, tankers and gas-carriers. Ferryboats vessels (including passengers) to/from Italian ports are allowed. Both shipping lines and passengers should respect the safety protocols. Actually all nationalities are allowed to enter in Albania. The yachts and other touristic boats are allowed in ports. From 3rd May, travellers from Greece and North Macedonia may enter Albania freely without obligatory quarantinee.

There are no restrictions for movement inside country. The cargo transport and personal cars are allowed. Taxi service and public transport by bus is active (It is obligatory to wear the mask during travel and respect protocols).

People may also enter/re-enter Italy from these countries for humanitarian or health reasons that cannot be deferred, subject to express authorization from the Ministry of Health and in compliance with a specific procedure (see the section dedicated to India, Bangladesh, and Sri Lanka).

CONFINEMENT : The Gouvernement of Bangladesh has taken the following decisions in the current situation of (Covid-19) infection on 06.06.2021 : 
Bangladesh again extends public movement restrictions until 16th of June. A gazette notification to this effect on 6th June-21, saying no social, political and religious gatherings will be allowed during the period. Duration of the ongoing restriction has been extended 10 more days; while the existing restrictions on public movement and gathering, aimed at curbing the spread of deadly Covid-19 that has killed over 12,800 people around Bangladesh so far. Covid-19 situation in Bangladesh : Covid-19 detection rate in border districts (Indian variant ) of Bangladesh is alarmingly on the rise. Bangladesh reported 38(Thirty-eight) people died from Covid in 24 hours till 8:00am as of 6th June-21, according to the Directorate General of Health Services (DGHS). D Total number of deaths in the country has reached 12,838 with the death rate standing at 1.58 %. At least 1,676 new infections were recorded during the same period, taking the total number to 810,990. The Covid positivity rate was 10.73 % while the overall positivity rate is 13.41%. 
While on 5th of June : 43 Covid-19 patients were died (Of the 43 deceased – 30 men and 13 women) and affected 1,447 new cases in 24 hours to Saturday morning, highest since 10th of May. 


 Hospitals in five other districts (have borders with India) Satkhira, Chuadanga, Rajshahi, Noakhali, and Bagerhat were also struggling to accommodate an increasing number of coronavirus patients. Positivity rates of 30% and above from last week. Experts warned that the surge in infection will reach the heartland of the country soon. • Authorities in Satkhira (in Khulna Districts) on Saturday/5th June imposed a week-long lockdown in the district, following a sudden spike in Covid-19 cases. The decision has been taken to break the chain of coronavirus transmission after the positivity rate in the district was found to be 53%. More Covid cases have been detected in three upazilas -- Sadar, Kalaroa and Kaliganj bordering India. The infection is on the rise in other upazilas too. 
Genomic sequence of 80% of the samples tested in mid-May have matched the variant The Institute of Epidemiology, Disease Control and Research (IEDCR) has found evidence of community transmission of the Indian variant, lately named as Delta variant by World Health Organization (WHO), in the country.

NON ESSENTIAL BUSINESS' CLOSURE : Banks will continue to operate on weekdays until 2:00pm, However, branches will remain open until 2:30pm to complete their regular procedures. The University Grants Commission (UGC) has permitted all universities – both public and private – in the country to take exams of honours and masters classes in person. In the wake of the spread of Covid-19 virus since last year March-2020, the government shut down the country's educational institutions; would remain closed until 13th of June-21. The government has decided to ensure vaccination of all students before opening colleges and universities for in-person academic activities.

# □ BORDERS' CLOSURE :

⊠ OTHERS : "CoronaVac" is the fifth vaccine to be given the emergency use authorisation in Bangladesh. The vaccine has received emergency use authorization in 22 other countries. The DGDA gave the go ahead on June 3, after M/s Incepta Vaccine Ltd applied for its approval for emergency use. On May 12, China handed over a batch of 500,000 doses of its Sinopharm vaccine as a gift to Bangladesh. The government of China is going to send as many as 600,000 doses of Covid-19 vaccine to Bangladesh by June 13 as a gift. Approximately seven million doses will be shared with 17 Asian countries and entities including Bangladesh.

NONE : Businesses and services: Shops, including shopping malls, are operating reduced hours from 10:00Am to 8:00Pm. Industries may operate provided they implement social distancing measures. Many nonessential establishments, including dine-in eateries, educational institutions, recreational venues, and offices, must remain closed. The use of facemasks is mandatory in public. Businesses allowed to operate must refuse entry to anyone without a facemask; however, reports





indicate that enforcement and adherence are generally poor. **■** Emergency services including hospitals remain open. At short notice local authorities may lockdown buildings, streets and areas in order to control the spread of coronavirus.

Accommodation: Some hotels and guesthouses are open, but services and guest capacity are limited. In areas with high infection rates hotels and guesthouses may close completely.

Private vehicles, except for motorcycles used via ride-sharing platforms, can operate with capacity limits. Intercity trains and buses may run at half their normal seating capacity. Restaurants may also offer dine-in services at half capacity.

**B** BANGLADESH TRAVEL RESTRICTIONS: Restrictions on air travel in the nationwide lockdown implemented. Although domestic air travel is operating a limited service. Further restrictions may come into force at short notice. Bangladesh has suspended visa-on-arrival services until further notice; travelers must obtain a visa from their local Bangladeshi diplomatic mission.

Bangladesh Civil Aviation Authority suspends flights from Nepal from 10 May until further notice.

Bangladesh authorities impose ban on entry of travelers from India via land ports; air travel also suspended.

■ Passengers arriving from many other countries, including the UK, are required to complete a 14-day period of quarantine. In most cases this will be home quarantine; however, health officials at the point of entry may determine that a government facility, or approved hotel, must be used instead.

■ Passengers from Bahrain, Kuwait, and Qatar will have to complete a mandatory three-day quarantine period at government-designated hotels at their own expense.

• The cancellation of domestic and foreign flights has contributed to this crisis. At the same time, travel visas for tourists from many countries have been suspended for the time being.

### Covid: Anvisa updates guidelines for ports and vessels

### [Texto em português abaixo]

On April 30th, the National Health Surveillance Agency (ANVISA) published Technical Note 5/2021, which updates and effectively compiles the guidelines for ports and vessels in this period of the Covid pandemic.

The Technical Note brings a detailed definition for "close contact" in a vessel and the port area, with subtle but important differences. Thus, if there are thirty crew members or fewer on the vessel, they are all considered closed contacts and subject to quarantine.

Either way, the Technical Note states that if there is a possible or confirmed case of COVID-19 on a vessel coming from a foreign port, all the crewmembers shall be tested.

If there is a possible COVID-19 case, the vessel will be in quarantine for 14 days. However, the quarantine can be lifted from the tenth day onwards if all crewmembers are tested negative (PCR test)

The Technical Note leaves it open for the Authority to consider if the 14 days period will begin on the day that the sample for the test is collected on the day of the onset of the symptoms. Still, it states clearly that the 14 days period will restart if there is another case registered on board.

The prohibition of maritime cruises and the restriction of disembarking of crewmembers remain in place, except for those related to repatriation and medical or dental assistance, according to Ordinance No. 652 of January 25, 2021 and its updates.

Another relevant update occurred on May 14th, when ANVISA published Ordinance 653/2021, which bans passenger flights from and with a passage in India, maintaining similar bans for South Africa and the United Kingdom only cargo flights.

Travelers to Abu Dhabi are required present a negative PCR test result received within 96 hours of their scheduled departure, or within 72 hours if flying from the UK. Travelers from countries not on the 'green (link is external)' list are required to quarantine for 10 days, and all travellers will need to undergo additional tests based on their period of stay in the UAE.

### **UAE Visa Policies**

Tourist visas are being issued by the Dubai and Abu Dhabi authorities. Visitors can travel to Abu Dhabi by road but must present (link is external) a negative PCR test result issued within 48 hours or a negative DPI test result within 24 hours. Residents and visitors will need to undergo additional tests in the emirate based on their period of stay. This policy applies to US citizens. Holders of diplomatic passports are exempted from this decision.



All commercial vessels must now use the Maritime Arrivals Reporting System (MARS) for all vessel pre-arrival reporting. All vessels entering Australia that have a suspected case of COVID-19 on board will not be allowed to unload goods or disembark travellers until cleared to do so by the human biosecurity officer.

Where vessels have a suspected case of COVID-19 on board, a human biosecurity officer will screen for COVID-19, determine the appropriate course of action and issue directions.
